M1 Holds undergraduate (B.A.) and graduate (Ph.D.) degrees in history and a master's degree in library science. Had an extensive career in libraries and archives with local and regional historical societies, a state archives, and a Catholic archdiocese. After turning to teaching, has served as a faculty member in history departments at universities, both public and private; has served as an acting department chair and as the chair of search committees. Has also directed a strategic planning initiative for a private university. Currently an endowed chair holder (emeritus) in a Catholic university. Additional teaching experience in library science. Extensive consulting experience with libraries and archives. Has published nine books, mostly in American Catholic history, and has written extensively in professional journals; has also served on journal editorial boards and as an officer of professional associations.

M2 A Ph.D in clinical psychology, in private practice since 1987. Thirty-year long career as a professor of psychology at a local college. Lengthy association with a diocesan Consultation Center for Religious Personnel (now defunct). Has worked for over 30 years with religious men and women and approximately two dozen priests treating a variety of presenting problems including addiction to pornography, various interpersonal forms of sexual acting out, boundary and vow violations with minors and adult women and men. Has also helped many lay people (as children and/or as adults) deal with their victim-survivor issues and needs. Has provided consultation to diocesan officials and provincials regarding the proper ministerial disposition of treated individuals. Previous service as a member of an incident review board assisting a local female religious congregation. Served as coordinator of sexual harassment and discrimination policies for 17 years at a local university, conducting all that institution's investigations, chairing review boards and consulting on at least a monthly basis with the university president and attorney.

M3 Past president of a statewide nonprofit organization that identifies choices and provides services to help people of all ages, abilities and incomes to live at home. A licensed clinical social worker and earned a Master of Social Work degree from one of the nation's leading research universities. Named to the inaugural "60 over 60" class of the local state capitol's Business Journal; a 'Remarkable Woman in Business' by the same Business Journal; a statewide 'Advocacy Champion'; and National Association of Social Workers (NASW) Social Worker of the Year by the local state chapter. secretary of the Executive Committee of the International Women's Forum in the local state chapter. Has "walked the walk" not just "talked the talk" caring for both her parents until their deaths at 93 and 103.

M4 Graduated from a Catholic university with a Bachelor's in Education and then a Master's Degree in Education from a second Catholic university. Awarded by the undergraduate school with the Distinguished Alumna Award and for a term of nine years was a member of the Board of Trustees at that institution. Previously employed with the FBI and during the course of a 28-year career, served in four field offices and at FBI Headquarters. Fields of concentration were Foreign Counterintelligence, Counterespionage and Terrorism. Held several senior executive positions including Acting Director of the National Security Division and Deputy Assistant Director of the Administrative Division. Served for five weeks as the initial On Scene Commander

following the bombing of US embassies in two foreign nations. Awarded the US government's Distinguished Executive Award. Following retirement from the FBI, served the United States Conference of Catholic Bishops in a key leadership position in the Office of Child and Youth Protection, which was established to assist U.S. Catholic bishops with the priestly sexual abuse crisis. Also serves a Catholic Diocese as the vice-chair of the Ministerial Review Board.
